Minutes of the Parish Council Meeting held on 3rd September 2007

9.07.1 Apologies for Absence: Cllr. R. Holland; Jim Hakewill;

9.07.2 Declaration of Interests

Cllr. Littler declared his position as an Honorary Officer of the Mawsley Villagers Association (MVA) and a director of The Centre at Mawsley CIC.

9.07.7 Police Matters (brought forward by agreement)

PCSO Jason Parish distributed a copy of the monthly crime statistics. He said that the police were aware of the tension between youths of Broughton and Mawsley and said that the police were patrolling between the two villages all night on the previous Saturday because they had heard rumours. The police were being proactive and stopping groups of youths to tell them that they should stay out of trouble.

Cllr Moreton asked when the YTD ran from since the sat nav thefts did not seem to be reflected in the figures. PCSO Parish said that he would find out.

Cllr Littler said that information regarding drugs had been passed to the police but that no more had been heard. PCSO Parish said that the police would certainly act on the information.

Cllr Littler said that the parish council was still trying to location a possible site for the allotments, any land found would obviously be further from the village. Mr Horne said that some people who have allotments elsewhere might not want to move allotments twice, if a temporary site is found. The allotment association may be happy to just wait for Richard Barnwells land if they could definitely move on to it as soon as the option is up. If there is not certainty then we need to find other land.

Cllr Littler explained that Stock Land and Estates have the option on the land because they might build on it. There will be no certainty until they have made a definite decision.

Mr Horne said that it was frustrating because the parish council knew that it was their statutory duty to provide allotments. Cllr Littler said that this was difficult since the parish council had no land and no money. The clerk had been in contact with NALC on this issue but had not yet received a reply. Cllr King commented that the situation is very frustrated but it does seem that the parish council's hands are tied.

9.07.11 Planning matters

KET/2007/0674 10 Loddington Way. Single storey rear extension. Mawsley Parish Council supports this application but makes the following observations.

- 1. The House is **Part of the Article 4 area**, all window frames need to be wooden, and they are listed as UPVC on the application
- 2. The plan contains different colours with no key, the parish council is not aware therefore if non-standard building materials are to be used.

KET/2007/0643 Repositioning of plots to accommodate overhead cables. There was inadequate information on this for the council to consider this application.

KET/2007/0736 Two storey dwelling, land off Main Street. After discussion the council agreed on the following response:-

Mawsley parish council **OBJECTS** to this application on the following grounds:-

- 1. This house is over and above the agreed number of houses in the village. When the village was originally planned, this piece of land was excluded from any housing plans because of the presence of a Badger Sett.
- 2. The scale of the house is out of keeping with the houses surrounding it
- 3. The map seems to be incorrect since it encroaches on Mr Richard Barnwells land, a 2 metre ransom strip should run all the way around this piece of land the council also has the following observations
- 1. The plot is with the article 4 area and would need wooden windows and doors.
- 2. Is the badger sett unoccupied?
- 3. The badger fence would need to be moved i.e. reinstated to ensure that it joins up with the rest of the fence

KET/2007/0709 Change of plot numbers to 700 series from 600 series in Phase 6c. The council had no objection to this application so long as it was merely a change in plot number.

KET/2007/0733 Two storey dwelling, land off Scholars Row

The council objects to this planning application on the following grounds:-

This plot is shown on the original master plan of the village to be a shop. The parish council feels that this site should be used for a village amenity. No effort has been made to use this as a shop or amenity site. The building of a house would go against the agreed housing numbers in the village.

KET/2007/0730 Two storey dwelling. Land off Link Lane. The following response to be sent:-

Mawsley Parish Council is unsure if this plot is on the original master plan of the village. If it is on the original plan then they would have no objection to the application. Please could you confirm whether it is on the plan?

The parish council does has the following observation:-

1. The plot is within the **article 4** area and should therefore have wooden doors and windows rather than the upvc that are mentioned on the application

KET/2007/0774 3 Paddock End, loft conversion. The parish council supports this application.

9.07.12 Mawsley Community Fund

Cllr Littler reported that he is trying to co-ordinate a project to have the existing play equipment moved to the TCAM where it will be installed with new equipment for older children. Cllr Littler assumed that the parish council did not wish to oversee this project, this was confirmed. The budget from KBC is £45k but the total cost will be in the region of £67k. Cllr Littler asked in principle if the parish council would agree for a grant of £6,500 as a contribution toward the cost of the play area. This was proposed by Cllr King, seconded by Cllr Hazell and agreed unanimously.

Cllr Littler said that there was nothing to report. Cllr Hazell asked if the parish council was due to receive a report about the performance of TCAM. Clerk to check the lease to see whether a review is required. **ACTION 9.07.13**
