

## Mawsley Parish Council

### Minutes of the Parish Council Meeting held on 2<sup>nd</sup> February January 2009

**02.09.1 Apologies for Absence** Cllr. Barnwell; Julia Beckett; Tim Bellamy; PCSO Hopkins

**02.09.2 Declaration of Interests**

Cllr. Littler declared his position as Director of Mawsley Villagers Association Ltd. (MVA) and a director of The Centre at Mawsley CIC.

**02.09.3 Allotted time for members of the public**

Cllr. Littler reported that Victoria Perry had said that the bus route was due to be extended. There were two issues; a bus shelter and hard standing for the bus stop. Brenda Quinn said that the bus stop should be moved as the bus stop was in a boggy area; someone was sure to fall over soon. Mrs Quinn asked if it was possible for it to be paved? The Clerk reported that highways mentioned that they would look into paving the area. Clerk to chase and ask them to pave as a lady fell there last week. Frank Quinn had offered to do some work on the area free of charge. Clerk also to ask Highways if that is a good place for the bus stop as it is not near a lay by. The clerk should ask if a solution would be to put a temporary bus stop by the paved area until the area can be paved as it is dangerous now – surely this is a health and safety issue? Steve Draycott and Martin Bentley were at the meeting to discuss plans for the remembrance garden. They suggested that the gardening and wildlife club would be interested in designing and maintaining a plot of 30x90feet. This was thought to be a manageable plot size. They suggested a south west facing area in the centre of the area as the area towards the edge of the land sloped away quite steeply. They also thought that area was suitable as it would be fairly accessible from the path.

Cllr. Littler thanked Steve Draycott for his input. It was useful for the parish council to see his suggestion. Cllr. Littler said that it may be an idea for the Parish Council to discuss the whole area at the next meeting. Steve Draycott said that the Gardening and Wildlife Club were going to write some letters asking for funding. They have approached The Nationwide and Cllr. Victoria Perry. The club were also writing to Moulton College who may be able to assist. Cllr. Littler said that Spalding had obtained funding for a sensory garden as it had been designed with visually impaired people in mind. Steve Draycott suggested that they have a consultation on site for the village to give ideas as to how the garden should be set out.

Cllr. Littler asked if the councillors were in favour of the gardening and wildlife club's ideas? They were.

The wind farm action group will continue to leaflet Broughton as the group represents many villages and is independent of any Parish Councils.

The latest flyer produced by the action group will be distributed soon. It will concentrate on the viability (or lack of) of wind farms.

Cllr. Littler reported that Bedford Pilgrims have kindly offered some money towards the play area. Potentially they will donate up to £2,500. This would reduce the amount that the MVA needs from the Community Fund.

2. Precept. Cllr. King asked if the precept needed to increase? Cllr. Moreton said that if the precept only followed inflation then there would be a big jump if something suddenly needed. Cllr. Littler said that it had reduced down last year as the same amount was asked for and the

number of houses had increased. Cllr. Hazell said the precept should go up 4% per house in line with inflation.

Cllr. King could not support an increase and wanted to abstain from this vote. Cllr. Hazell voted a precept of £18,000. This was seconded by Cllr. Cope.
