04.09.1 Apologies for Absence none

04.09.2 Declaration of Interests

Cllr. Littler declared his position as Director of Mawsley Villagers Association Ltd. (MVA) and a director of The Centre at Mawsley CIC.

04.09.3 Allotted time for members of the public

Terry Woodward has lived in Mawsley for six years but this is the first year that he has been disturbed by bird scarers, he assumes that the noise is caused by bird scarers as it is too noisy to be a shotgun. Mr Woodward has heard them as early as 5:45am. He has been asked by the Borough Council to keep a log. The Borough Council has had two or three complaints. Perhaps an article in the newsletter but that may encourage people to complain who aren't really upset by it? Cllr. Littler had put a post on the forum to ask where the scarers were so Cllr. Barnwell could say who the farmers are. There had been no response to this although people on the forum said that it was still a problem. Cllr. Barnwell started by saying that they are not his! He has been making investigations as the scarers are waking him up. There is a nationally agreed time, before which you are not allowed to use them. They are certainly not allowed to go all night which they are. Clerk to write to environmental health about this ACTION 04.09.3.1.

Steve Draycott and Martin Bentley were attending the meeting on behalf of the gardening and wildlife club. Steve Draycott mentioned a water pump at the bottom of Cowslip Hill. The gardening club had pegged out a suggested memorial garden over the weekend. The area of the garden was (90ft x 75ft) which amounts to less than 5% of the total open area. The area was the easiest area for the gardening group in respect of ease of access for disabled and ease for the club to maintain. All the parish councillors had been to visit over the weekend. Cllr. Littler said that a decision on location should be deferred until the path and eco meadow are complete so it can be considered in line with other proposed areas such as the orchard. Cllr. Littler added that the resident from the bottom house in Jibwood has complained about the proposed location of the memorial garden as they feel that it is too close to their house. Cllr. Moreton agreed that all other areas need to be considered. Cllr. Littler added that the gardening and wildlife club may wish to think about the size of the memorial garden, bearing in mind the poor quality of the soil

Cllr. King joined meeting at this point.

The smaller the garden the easier it is to maintain and to treat the soil. Members of the gardening club may move and then the issue of maintenance would need to be considered. Cllr. Moreton said we need to understand what is going in the garden to see what size is needed. Steve Draycott said that they wanted to base it on Anglesey Abbey with winding paths and miniature gardens. Cllr. Barnwell asked if it was positioned intentionally at an angle to the path? Steve said many groups in the village wanted to maintain areas of the garden. Cllr. Littler said that until more progress has been made with the eco meadow as a whole there is no more to discuss. Cllr. Barnwell asked if KBC would be responsible for the land? Cllr. Littler said that KBC would maintain the eco meadow but the village would be responsible for the garden. Cllr. Littler said that the Parish Council needs to consider the agreement with the Borough Council on the maintenance of the areas. Tim Bellamy has already asked the legal team about this.
